#### 556. CHAIRMAN'S REPORT

The Chair welcomed all attendees to the meeting and referred to the forth coming general election.

# 560. HARBOUR OPERATIONS

Nicola Gandy addressed Commissioner advising of a recent incident where a van accidentally drove off the harbour on to the beach. Nicola advised that insurers had been informed and measures were being put in place to create a barrier at this location.

# **Fishing Fleet**

The fleet is currently operating well with no reported issues.

# Saundersfoot In Bloom

All flowers needed for our planters have now been purchased, the team aim to have all planted and in situ by the first week of July, going with various colours of non-stop

begonias and lobelia for the planters, it was collectively decided that bright vibrant colours would be our vision for the planters. David Cox the Gardener working for the SCC has been assisting the Harbour Master with the planting of five hanging baskets to be located around the harbour, again to bring vibrant colours to different areas.

# **Harbour Patrol Boat**

The new Harbour Patrol Boat is being used actively this season to ensure a good presence is maintained in the Harbour and the bay, so far, the boat just being out has reduced the number of speeding vessels dramatically.

# **Tripping Boat Operator Advert**

Following previous agreement during discussions with the board, an advert for a further commercial tripping boat operator will be published shortly

# **Sluice Actuator Install**

Rotork have been on site and completed the pre-install survey, however there has been a slight delay with the installation, we are awaiting confirmation from Rotork of a firm installation date that will hopefully be very soon.

#### 561. COMMERIAL OPERATIONS

Nicola Gandy addressed the commissioners.

#### **WB** Griffiths

Ongoing issues continue. WB Griffiths believe that the leak at the Marine Centre has been resolved but this will be tested during the next spell of poor weather.

WB Griffiths have advised that the Tulips will be removed on week commencing 8/7/2024.

# Accommodation

Performing well.

Bookings are up 46% on last year so far.

Commissioners had been advised by a separate e-mail that the Harbour would be terminating the contract with Stay Pembrokeshire in October. A tender for a property management and cleaning contract has been placed on Sell2Wales. Booking management systems are being explored. Nicola advised that this move will be positive for the harbour as it will allow far more control over our rooms and pricing strategy.

## **Tenants**

Unit 7 – Ocean jewellery will be vacating in July. A new tenant will be taking on the lease.

The restaurant is on the market with EJ Hales

A French Style van selling doughnuts is in a temporary position and has received positive feedback. It will be located to the front of the Welcome Centre once it gets planning permission which is expected after 17<sup>th</sup> July.

The EV charging points are awaiting planning.

The Chair asked why these require planning permission, Nicola advised on permitted development rights in Wales.

#### **Stakeholders**

Keep Wales Tidy will be using the harbour as a pilot area for angling rubbish collection.

- The Chairman suggested that a Strategy Group be created which draws on the
  intellect of representatives of the harbour users and the wider community. The
  membership of the Strategy Group was suggested to consist of Commissioners,
  CEO, representative of the fishing fleet, representative of the leisure boat fleet and
  a key representatives of the community, along with some other key members such
  as the education sector, Ports sector and County Council.
- Commissioners unanimously agreed that a Strategy for the next 5-10 years was required and that a Strategy group be formed as proposed by the Chairman.
- The Commissioners voted to in favour of the production of a Strategy and the creation of a working Strategy Group
